RESOLUTION 2021-261: Authorization of Emergency Sewer and Storm Line Repair between 7th & 8th Streets on East Central Blvd (RE: Donerite Construction):

WHEREAS, pursuant to N.J.S.A. 40A:11-6 et seq., any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, on November 01, 2021 the Borough Administrator was advised that several storm and sanitary sewer laterals which provides for sanitary and storm sewer drainage on East Central Blvd were not functioning properly and needed immediately repair; and

WHEREAS, storm and sanitary sewers are vital to the health, safety and wellbeing of all residents and the borough of Palisades Park and are essential for daily, and

WHEREAS, the Governing body further finds that the emergency was caused by the Bergen County Roads Department's Storm Water Sewer upgrade project; and

WHEREAS, the Governing body further finds that the damage cause was in no way the fault of the homeowners effected; and

WHEREAS, it was determined that the immediate repairs were necessary to restore the sanitary and storms laterals, and

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available; and

WHEREAS, authorization has been given to Donerite Construction to commence with the necessary repairs to restore the vital functions of the Borough's Sanitary and Storm sewers in amount not to exceed \$27,000.00,

NOW, THEREFORE, BE IT RESOLVED that based upon the certification and representations of the Certified Purchasing Agent, the Mayor and Council do hereby authorize the payment to Donerite Construction, 1561 West Street Fort Lee, New Jersey 07024, in the amount of \$24,750.00 for the purpose of the emergency repair of sanitary and storm sewer laterals between 7th & 8th Streets on East Central Blvd; and

WHEREAS, pursuant to N.J.S.A. 40A:11-6 et seq., any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, an emergency has arisen as a result of Tropical Storm Ida which occurred on September 1, 2021. Significant damage was sustained to portions of 8th Street, and Hillside Ave. This emergency appropriation is being issued consistent with Executive Order #259 issued by Governor Philip Murphy on September 1, 2021, and the Federal Disaster Declaration issued by President Biden on September 5, 2021, FEMA-4614-DR-NJ; and

WHEREAS, N.J.S.A. 40A:4-46 provides for the creation on an emergency appropriation for the purpose mentioned above, and no provision was made in the 2021 budget for this purpose; and

WHEREAS, that in accordance with N.J.S.A. 40A:4-48:

- An emergency appropriation is hereby made for Tropical Storm Ida Storm Repair Other Expenses in the total amount of \$10,810.00.
- O Drainage repair work at 445 8th Street in the amount of \$4,360.00
- Remove and replace apron/curb to alleviate flooding at 519 Hillside Ave in the amount of \$\$6,450.00

WHEREAS, the Chief Financial Officer has certified that there are sufficient funds available; and

WHEREAS, authorization has been given to Donerite Construction to commence with the necessary repairs to restore the vital functions of the Boroughs Sanitary and Storm sewers in amount not to exceed \$10,810.00,

Mayor Chung also spoke regarding the new residential parking program. There was a problem with non-residents abusing the free parking spaces available on local streets. The hours of enforcement would be from 12:00 A.M. – 9:00 A.M. Monday thru Friday. Residents were advised to pay \$20 for two years. He believed this would help retailers as well as the DPW to clear snow in the event of inclement weather. Mayor Chung announced that this parking program was first introduced in June and adopted in July of 2021. At that time, it was made clear that registration would begin November 15th thru December 31st. He announced there will be a town meeting on December 1st at 6:30 P.M. that will help answer more questions regarding the new parking program.

Officer-in-Charge, Captain Shawn Lee, updated the residents on two thefts involving elderly victims. It is believed the two incidents are linked and involve victims being stripped of their jewelry without their knowledge. Detectives are working with Fort Lee who have had similar cases.

To Open Meeting to the Public

PUBLIC PARTICIPATION:

Sung Kim (336 7th St.) – Believes there are too many duplexes creating many problems. He stated that Central Blvd, from Broad Ave to Grand Ave, the street is dirty and has never been paved. He commented on the fee for the new parking program.

Marsha Schor (50 Henry Ave) – Said the guest pass is a good idea for the many illegal apartments in town. Also the public should know that if an illegal apartment resident is forced to move out, it is up to the landlord to pay for living expenses until a new legal apartment is found.

<u>Susan Brauer (50 Henry Ave)</u> – Asked with the new parking program not allowing non-residents from parking after midnight, what will happen when patrons of businesses stay past that time?

<u>Youngmin Jung</u> – Recently read in the Korean newspaper the details of the new parking program. He had a question about the visitor parking fees. He stated that many residents were not informed.

<u>Neris Papoters</u> – Wanted to know if residents would be ticketed for parking cars on the sidewalk. She asked for a family with four cars, the parking registration fee would be \$80?

<u>Youbong Won-Yoon</u> – Stated that she would like to see this parking program be implemented in another 6 months for residents to have more time to register. She asked that the December 1st meeting time be moved to 8:00 P.M. She asked who the "cloud" service provider was.

Melanie Comas (83 West Harwood) – Said there is a tow away sign in front of her home stating "No Parking from 12:00 A.M. – 9:00 A.M." She asked how this differed from the new parking rules. She said the business across the street was taking up parking spaces all times of the day. She asked how late a business can stay open in town. Ms. Comas stated that the extreme trucking activity on Grand Avenue has worsened.

<u>Gerry White</u> – Asked regarding Resolution #2021-265 & #2021-261. She also commented that she disliked residents having to pay a parking fee for registration.

<u>Jung Eun Kim (306B 3rd St.)</u> – Stated that residents pay taxes and all other property taxes so she wanted to know why they had to pay for the new parking program.

<u>Peter Longo</u> – Stated that the method of holding questions until the end of the meeting was upsetting. Will the resident parking stickers be obsolete? He asked if he will be ticketed if he moves his car to the street and gives his driveway to his visitors. Also, how will the town handle residents with company cars?

<u>Susan Brauer (50 Henry Ave)</u> – Last year the assembly introduced a bill to alleviate school taxes to some seniors, and she asked if the Mayor and Council were aware. The Zoning Board and the Planning Board should thoroughly inspect requests for expansions before they are considered. She went through the Best Practices Worksheet and read through items that the town should implement.

Soo Chung (237 Central Blvd.) – She asked about Resolution #2021-261. She asked about the new parking program.

Soonae Choe (141 E. Central Blvd) – She had been living in town for 17 years, and her home had 6 cars. She thought the town should not be charging for residents and guests to park on the street. She was worried about future hurricanes affecting her home. She commented on the streets near Shoprite, and trucks were not stopping at stop signs. She asked why so many trucks were always in that area.

To Close Public Portion

The Borough Administrator proceeded to answer the public's questions. Mr. David Lorenzo stated that all residents need to adhere to parking laws, and the Police Dept. will continue to monitor the situation. Regarding questions about Overpeck Park; it was a County run project to help improve conditions, and it had nothing to do with Palisades Park. For Resolution #2021-261, there were two broken sewer lines and emergency repair had to be done. Regarding the Mariners Bank Resolution, the Borough was 100% refunded.

Mayor Chris Chung said that the construction on Central Blvd was rescheduled to be paved due to Hurricane Ida. Regarding the school tax waiver, he stated he is aware and waiting for updates on this proposed bill. To answer Ms. Comas, the Mayor advised he has addressed her concerns previously and that is out of our jurisdiction. John Schettino advised it is highly unlikely for the State to make the speed limit change on Grand Ave. Mr. Schettino reminded the public that the State law requires all public entities one opportunity to ask a question or make a statement. The Governing Body did not have to answer any questions if they did not want to although he would not advise this. In terms of what occurs

during the public portion, Mr. Schettino stated that the Mayor and Council were doing what was consistently done throughout the State of NJ and more so by opening up twice to the public and attempting to answer the questions.

Councilman Kim asked what the set hours were for businesses. Mr. Lorenzo answered it depends on the type of business, and it varies. Mr. Kim asked who was responsible for Grand Avenue, Mr. Lorenzo advised it was a State road.

Mayor Chung will get back to the resident asking for the "cloud" provider. He announced that beginning next month a Korean interpreter will be provided for residents who need it. He advised that the next Mayor & Council Meeting will take place on December 15th at 5:00 P.M. and the Reorganization Meeting will be January 3rd at 10:00 A.M.
