The Borough Attorney, John Schettino, suggested that the public should be heard before the Mayor and Council took any action.

The Mayor stated that he had called the Special Meeting to discuss the Officer-in-Charge position. As previously discussed and agreed upon, until the final decision was made to make a Police Chief, the two Captains would rotate. The Mayor made a recommendation to rotate back to Captain Anthony Espino as OIC effective May 10, 2022.

Councilwoman Jang stated that the Mayor and Council should discuss the Police Director position. The Mayor answered that this was not a part of the agenda, and today was about switching the OIC positions. Councilwoman Jang said that one Officer-in-Charge may not be enough to carry all the police matters. As a Councilwoman, she was thinking about getting extra help. Mr. Schettino stated that before the Council makes a final decision, it should be decided if they wanted a Police Director or not. The Mayor stated that this could be discussed at the May meeting. Mr. Schettino advised the Mayor and Council that they could discuss the position of the Police Director in Closed Session, and if any specific individuals were going to be discussed, Mr. Schettino would have to provide those individuals with RICE notices.

Councilman Vietri stated that the three consultants were fired and now Councilwoman Jang wanted to hire one police director. The three consultants had over 100 years of combined experience. Councilwoman Jang stated that it would be helpful to have a Police Director or someone who would work with the Officer-in-Charge.

Susan Brauer (50 Henry Ave) – Asked how long Captain Espino had been on the force. Councilman Vietri stated 23 years. Ms. Brauer said that 20 years was a lot of good experience, and he would have not been made Captain if he was not good at what he did. She addressed Councilwoman Jang and said she had only been on the Council for 5 months and maybe she needed a little more time to immerse herself before suggesting a PD Director.

Marsha Schor (50 Henry Ave) – Asked Ms. Jang that when she was running or on the Board, no questions were ever brought up about the other Officer-in-Charge. Now that the town decided to put someone new, Ms. Jang had all these questions. Ms. Schor asked Ms. Jang why she had not said anything before. Ms.

Jang responded that she had said things about this in March and again in April. She said there needed to be someone strong in charge for the Police Department.

<u>Gerry White</u> – Asked if the Mayor and Council was again appointing someone as the Officer-in-Charge and not a Chief for an indefinite period of time. The Mayor answered that was correct.

<u>Neris Papoters</u> – Said that there were three police consultants, but the situation with the police department got worse so she thought there needed to be different change.

Councilman Vietri asked what the reason for the change was. The Mayor answered that everyone agreed in the beginning that the Officers-in-Charge would be on a rotational basis. He said it was good time to make the change. He said Captain Lee was in charge for almost a year. Councilman Vietri said that when Capt. Lee was in charge, he started the Honor Guard, brought the PD up and forward, and started the process for getting new guns.
