Thomas Yook (300 Highland Ave) – Spoke about the mold situation at the Borough Hall.

<u>Thomas Matarazzo (33 E. Harwood Terrace)</u> – Stated that he wrote a letter on June 15, 2022. He was employed as the Swim Club Manager from 1990-1991 and again for 1997-2014. He wanted to be reimbursed for unused sick time.

<u>Youbong Won-Yoon (268 Highland Ave)</u> – Asked about #2022-206. She wanted to know if the mold investigation was complete and wanted to know the results of the investigation.

<u>Douglas Ham (137 Morningside Lane)</u> – Stated that his home was being flooded by water during rainstorms. He stated that this issue starting happening after the roads were repaved.

<u>Frank Appice (313 4th Street)</u> – Stated that he was also experiencing issues with his home being flooded with water. A resident from 317 4th Street also stated that she was having the same problem.

Eric Bortz (221 Columbus Ave) - Asked about Ordinance #2022-5.

<u>Vincent Carnovale</u> – Asked about placing a traffic light on E. Homestead Ave. People still drove up the wrong way on the off ramp on Route 46.

Mr. Schettino answered that with respect to the mold, most buildings had mold. It was when it got to an unacceptable level that it posed a health hazard to either the people that work or live in the home. In this case, the mold problem did go back several years, but it did not rise to the level of being a health hazard. Now the Borough was at the point where it did pose a health hazard and a decision had to be made by the Mayor and Council as to how to address and remediate the mold. One consideration was to remediate and renovate this building, which would be an extensive amount of work. The second consideration was to build a new municipal building as many other Bergen County towns were doing. However, if this building were unsafe to work in, then the people had to be relocated. The Resolution on tonight was not approving a lease. The Resolution was authorizing the Borough Administrator to look into and come back to the Governing Body with locations and a potential lease that employees could relocate to. The Borough could not be in a position where the building had to be vacated and there was no place for the employees to go. No final decisions had been made.

Mr. Schettino answered Mr. Matarazzo's question about sick time.

With regard to the flooding, Mr. Lorenzo stated that the Borough Engineer would be asked to look at all three locations.

Councilwoman Jang said that the Borough had a flood problem last year as well. The Borough had to come up with a fundamental solution to the flooding. She stated that as much as the employees were in danger due to the mold problem, even more than that the residents' flood problems should be taken care of as soon as possible. She said that the mold problem was going on for 6-7 months. The Borough Administrator and the Deputy Borough Administrator had asked the Council what should be done to resolve the mold situation. She said she had reviewed the mold reports, and it seemed that 80% of the

offices were okay to be occupied, but about 20% had problems. She thought that they needed to have a professional decision stating that the Borough needed to evacuate entirely. Rather than moving out and spending the allocated bond money, she thought the bond could be spent in a better way.

Councilwoman Pirrera stated that she had some experience with mold because she was in property management. She said that it was impossible for the Council to understand the mold reports. They needed the opinion of experts. She said there were too many breaches to correct. She said that they did not want to wait until the building was condemned; this would be the worst possible situation. She said they would have to be very careful about making a decision in a timely manner. In the meantime, she was concerned about the employees. She said she cares about the people at the Borough and what goes on.

Councilwoman Jang asked about paying for the building that was on fire. Mr. Lorenzo answered. She asked about feeding stray cats. Mr. Lorenzo said that it was illegal to feed stray cats.

WHEREAS, the Borough of Palisades Park and the County of Bergen with to enter into a Shared

Services Agreement for the snow plow operations and salting on the county roads located within the Borough; and

WHEREAS, the County wishes to employ the services of the Borough for the snow plow operations and salting of the county roads located in the Borough for a period of two snow seasons commencing October 1, 2022 and ending April 30, 2024; and

WHEREAS, the County of Bergen will compensate the Borough for conducting the snow plow operations and salting at a rate of \$115.00 per hour of active plowing with the Borough agreeing to provide the necessary equipment and personnel required to perform the snow plowing operating; and

WHEREAS, the Borough Administrator and Borough Attorney have reviewed the Shared Services Agreement between the Borough of Palisades Park and the County of Bergen for the snow plow operations and salting of the county roads in the Borough, a copy of which is attached hereto and incorporated herein by reference, and recommend the approval of same.

WHEREAS, pursuant to N.J.S.A. 40A:11-6 et seq., any contract may be negotiated or awarded for a contracting unit without public advertising for bids and bidding therefore, notwithstanding that the contract price will exceed the bid threshold, when an emergency affecting the public health, safety or welfare requires the immediate delivery of goods or the performance of services; and

WHEREAS, on the evening of Saturday, July 2, 2022 a major multi alarm fire occurred in the Borough of Palisades Park at 27 Fairview Street; and

WHEREAS, due to the severity of the fire, the Fire Official notified the Borough Administrator of the need to obtain heavy equipment necessary to access concealed areas of the building on fire to bring it under control, specifically the roof and related areas; and

WHEREAS, the Fire Official had contacted the building owner who indicated that there was no insurance carrier in place to provide for such authorization and services to contain the emergency currently existing and exposing the Borough and its residents; and

WHEREAS, it was determined by the Fire Official that the Fire Department and the Borough needed to take emergent actions, as the situation required specialized equipment and professionals not available to the Borough or its emergency personnel and the expertise and services needed to assist the Firefighters and to contain and stop the fire and to secure the building and the safety of the Borough and its residents; and

WHEREAS, authorization had been granted to Donerite Construction of 1561 West Street Fort Lee, New Jersey 07024 to provide all necessary equipment, labor and services as required by the Borough under the direction of the Fire Official to assist in the matter during and as a result of the fire.

NOW, THEREFORE, BE IT RESOLVED that based upon the certification and representations of the Certified Purchasing Agent, the Mayor and Council do hereby authorize the payment to Donerite Construction 1561 West Street Fort Lee NJ, New Jersey 07024 in the amount of \$74,213.13 for the purpose of the emergency work services performed as directed and as a result of the July 02, 2022 Fore as identified above; and

BOROUGH OF PALISADES PARK
BERGEN COUNTY, NEW JERSEY

ORDINANCE #2022-6

AN ORDINANCE AMENDING CHAPTER 58 OF THE CODE OF THE BOROUGH OF PALISADES PARK ENTITLED "POLICE DEPARTMENT".

BE IT ORDAINED, by the Mayor and Council of the Borough of Palisades Park, County of Bergen and State of New Jersey, that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged:

Ch.58. POLICE DEPARTMENT

Sec. 58-4.2.1 Position of Police Director created.

In the absence of a Police Director, the Appropriate Authority shall be the Mayor and Council.

Sec. 58-4.4. Police Committee as Appropriate Authority.

In the absence of a Police Director, the Appropriate Authority shall be the Mayor and Council.

If any section, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance, but shall be confirmed in its effect to the section, sentence or other part of this Ordinance directly involved in the controversy which such judgment shall be rendered.

All Ordinances of the Borough of Palisades Park which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

This Ordinance shall take effect immediately upon passage and publication as provided by law.

Councilwoman Jang asked if the Police Committee and the Appropriate Authority were two separate things. Mr. Schettino answered that this Ordinance was already in place, but there was some confusion with the Ordinance. In the absence of a Police Director, the Governing Body would be the Appropriate Authory.

ORDINANCE #2022-5

AN ORDINANCE AMENDING CHAPTER 282 OF THE CODE OF THE BOROUGH OF PALISADES PARK ENTITLED "VEHICLES AND TRAFFIC"

BE IT ORDAINED, by the Mayor and Council of the Borough of Palisades Park, County of Bergen and State of New Jersey, that those portions of the aforesaid set forth below are hereby amended as follows and that those portions of the Ordinance not set forth below shall remain unchanged:

Ch. 282 VEHICLES AND TRAFFIC.

Sec. 282-44.1 Restrictions on Parking.

No person shall park a vehicle upon any of the streets within the Borough of Palisades Park during the applicable days and hours of restrictions set forth herein unless the vehicle is owned or operated on a regular basis by a Palisades Park resident and the vehicle has a current residential parking permit between the hours of 12 a.m., and 9 a.m., Sunday through Friday, except legal holidays, with the following listed exceptions:

Bergen Boulevard, Grand Avenue, Fairview Street, Union Street and Fair Street.

Commercial Avenue from its intersection with West Central Boulevard northerly to its terminus.

East Columbia Avenue from Broad Avenue to Roff Avenue.

West Ruby Avenue from Grand Avenue to its terminus.

West Palisades Boulevard from Grand Avenue westerly to its terminus.

West Edsall Boulevard from Commercial Avenue westerly to its terminus.

§ 282-44.2 Regulations not exclusive.

A. The provisions of this article imposing a time limit on parking shall not relieve any person of the duty to observe other more restrictive provisions prohibiting or limiting stopping, standing or parking as set forth in N.J.S.A. 39:4-138 or any other municipal parking ordinances.

B. The creation of a residential parking permit shall have no effect upon meter parking spaces or business parking areas. Parking-metered spaces shall be available to all vehicles, with or without a residential

permit. A residential parking permit shall not exempt a resident when parked in a metered space from purchasing time from the meter at the established rate, except as set forth herein.

§ 282-44.3 Enforcement.

This article shall be enforced by the Traffic Department of the Borough of Palisades Park. Enforcement of this article may also be enforced by any civilian employee(s) known as "Traffic Enforcement Officers" appointed by the Mayor and Council.

§ 282-44.4 Rules and regulations.

The following rules and regulations shall apply to the Borough of Palisades Park Resident Parking Program: A. A resident owner of a vehicle shall be eligible for a parking permit pursuant to the following requirements: The vehicle must be owned by a person residing in the Borough of Palisades Park and have a gross weight of no more than 2.5 tons.

<u>B.</u> Proof of residency of the owner of a vehicle must be presented when applying for a permit. The following shall be accepted as proof of residency:

- (1) A copy of a valid New Jersey driver's license reflecting the applicant's residence in the Borough of Palisades Park accompanied by two proofs of residency (e.g., phone, United Water, PSE&G); and
- (2) A copy of a valid New Jersey motor vehicle registration for the vehicle for which the permit is sought, reflecting the applicant's address in the Borough of Palisades Park. In the case of a vehicle claimed to be leased and used by a Palisades Park resident, a copy of a valid motor vehicle registration and a copy of the automobile lease agreement shall be presented to the Police Department.
 - (3) A copy of a valid insurance card for the vehicle for which the permit is sought.

C.

A resident having complied with Section B shall pay a fee of up to \$20 per vehicle for a 3 year residential parking permit from the date of issuance.

- (1) Any resident over the age of 65 at the date of their application after complying with section B shall pay a fee up to \$10 for a 3 year residential parking permit from the date of issuance.
 - **a.** If a resident prior to age 65 has been issued a permit the senior citizen permit discount shall not apply until the permit period has expired.

Visitor permits.

A. The Borough of Palisades Park shall have the authority to issue a temporary parking permit to parties visiting a resident of the Borough. Visitor passes will be available for purchase daily for a cost up to \$15, and monthly for a cost up to \$300. Daily Visitor passes can only be purchased by the same vehicle a maximum of ten times in any calendar month period.

§ 282-44.5 Visitor passes.

Visitor passes shall be available for purchase to any visitor who meets one of the following qualifications: $\underline{\mathbf{A}}$. Are in need of parking on residential streets during designated residential parking permit hours of Monday through Friday 12 am -9 am; except during legal holidays.

B. Visitor passes shall be available for purchase via a link in the borough's website,

MyPalisadesPark.com or in person at the Borough Hall in daily and monthly increments. The price of visitor passes shall be up to \$15 for a daily pass, and up to \$300 for a monthly pass.

<u>C.</u> Visitor passes will be monitored electronically using a license plate recognition system and any vehicle that is found to be in violation of residential parking permit hours will be issued a ticket.

§ 282-44.6 Use of visitor passes.

A. The presumption shall be that any vehicle parked more than three city blocks from the household for which the visitor pass has been issued shall not be visiting such household and shall be subject to violations and penalties set forth in § 282-44.10 of this article.

§ 282-44.7 Exceptions to visitor pass requirements.

A "visitor" shall also be defined as follows:

- <u>A.</u> Contractor/services and delivery vehicles. Contractor, services and delivery vehicles bearing the name and address of the commercial vehicle may park without a permit during the times they are rendering a service within the Borough.
- **B.** Emergency and utility vehicles. Emergency vehicles and utility vehicles, such as gas, electric, water, telecommunications and other similar vehicles, may park without a permit during the times they are rendering services within the Borough.
- $\underline{\mathbf{C}}$. Health-care providers. Doctors, nurses, home health aides or other medical professionals may park their vehicles within the Borough during the times that they are rendering assistance and/or health care service to the residents of the Borough.
- <u>D.</u> Nonresident property owners of Palisades Park. Any nonresident property owner of Palisades Park may park his or her vehicles within the Borough during the times he or she are at the property owned by him or her.

§ 282-44.8 Abuse of visitor pass.

Any abuse in the use of a visitor pass will result in its revocation in the following circumstances:

A. When any such pass is used on any vehicle owned and controlled by a resident.

§ 282-44.9 Terms of permits.

[Amended 3-28-2017 by Ord. No. 2017-3]

Resident permits will have a predetermined expiration date, and an expectancy not to exceed three years. Any vehicle bearing an expired resident permit and parked on a street posted "Permit Parking Only" shall be subject to the same penalty as a vehicle parked on the street without a resident parking permit.

§ 282-44.10 Violations and penalties.

<u>A.</u> Any vehicle parked on a street posted "Permit Parking Only" without a valid resident permit or visitor pass shall be subject to a parking fine not to exceed \$50 for each three-hour period or a portion thereof of a twenty-four-hour period that said vehicle is parked in violation of this article.

B. Any vehicle violating this article shall be subject to towing by the Borough of Palisades Park and shall not be released until the payment of the appropriate charges.

§ 282-44.11 Promulgation of rules and regulations.

The Traffic Department shall have the authority to formulate and promulgate rules and regulations pertaining to this article as it deems necessary and proper. The Traffic Department shall provide copies of any regulations adopted under this article to the Borough Clerk's office within 30 days of their adoption, and the Borough Clerk shall present same to the governing body for its approval. The Traffic Department and Traffic Enforcement Officers shall be entitled, in their discretion, to verify any information appropriate to the enforcement of this article. The Traffic Department shall have the power to issue summonses for violation of the article.

§ 282-44.12 Residents on Broad Avenue and Columbia Avenue.

Persons residing on Broad Avenue or on lots contiguous to Broad Avenue and persons residing on Columbia Avenue which residence are in front of metered parking shall have issued a separate residential parking permit.

§ 282-44.13 Special parking permit.

Persons issued a special residential parking permit declaring their residence to be on Broad Avenue or on lots contiguous to Broad Avenue and persons residing on Columbia Avenue which residences are in front of metered parking shall be allowed to park their vehicles in accordance with these regulations at needed spaces on Broad Avenue from 6:00 p.m. to 9:00 p.m. and be exempt from purchasing time from the meter at the established rate.

§ 282-44.14 Application for parking permits.

Applications for parking permits shall be made on forms provided by the Traffic Department and submitted to the Traffic Department from website portal located on Borough's website.

If any section, sentence or other part of this Ordinance is adjudged unconstitutional or invalid, such judgment shall not affect, impair, or invalidate the remainder of this Ordinance, but shall be confirmed in its effect to the section, sentence or other part of this Ordinance directly involved in the controversy which such judgment shall be rendered.

All Ordinances of the Borough of Palisades Park which are inconsistent with the provisions of this ordinance are hereby repealed to the extent of such inconsistency.

This Ordinance shall take effect immediately upon passage and publication as provided by law.

Susan Brauer (50 Henry Ave) – Mentioned Councilwoman Jang's statement about perhaps using the three million dollar bond for the mold for something else. It was her understanding that the bond ordinance could only be used to rectify anything to do with the mold. This was correct. She said that no one wanted to spend money, but this had to do with people's health.

<u>Chris Ham (137 Morningside Lane)</u> – Asked what would be the next step for the flooding. Mr. Lorenzo stated that the Borough Engineer would be visiting.

<u>Thomas Yook</u> – Said he had a good idea for the mold. He asked the Mayor and Council to decide whether or not to move to a temporary space by referendum. He spoke about the State Comptroller's report.

<u>Marsha Schor (50 Henry Ave)</u> – Regarding the driveways slanting down, the Board of Adjustment and the Planning Board should advise the builders when they come before these boards to elevate the driveways. Mr. Lorenzo answered other questions from the public regarding the mold and the flooding. Mr. Schettino said that recently there was an article about the State Comptroller's report. 90% of the towns surveyed were misinterpreting the sick pay law. There was only one town that made corrections, and that town was Palisades Park. All of the recommendations by the State Comptroller's report were addressed. The property maintenance issue would be addressed by the Property Maintenance officer. Mr. Schettino said that by State law, the School Board was separate from the Mayor and Council. The School Board was responsible for the school facilities. The Mayor and Council had no control over how the School Board utilized the funds that they received from the taxpayers. Councilman Kim asked Councilwoman Jang about the mold situation at the school because she was the School Board liaison. Councilwoman Jang said that when she was serving on the School Board, there was a mold problem. During vacation, they cleaned up the mold for two months. It was clarified that there was no mold issue at the school.
