Mayor Kim asked if anyone had any questions. Councilwoman Jang asked why there was a need to hire another Police Consultant. She said there was the Chief of Police and a Captain. She spoke about the past three Police Consultants, and she said the Consultants were not worth the money. She asked why the Borough needed to pay Mr. Lorenzo's legal bill. She said he was not involved in the Election case as the Borough Administrator. She said he was not entitled to indemnification. Councilwoman Jang said that Councilman Vietri had a conflict of interest with the Police Department last year due to certain lawsuits. She asked if he still had a conflict. The Mayor clarified which Resolutions Councilwoman Jang had questions about. It was Resolutions #2023-68, #2023-79.

Councilwoman Jang stated that the Bergen County Prosecutor's Office Assessment of the Palisades Park Police Department report dated March 1, 2023 should be open to the public.

Mayor Kim addressed Councilwoman Jang's questions about the Police Consultant. He said that Hillard Heintze gave recommendations but these were not addressed. The Police Consultant would be hired to rectify the situation mentioned in the Bergen County Prosecutor's report. Mr. Moench said that the issue with the BCPO report was that it had put the Borough on notice to work on certain areas that need improvement. If they don't get improved, depending on what the issue was, there could be legal liability to the Borough, there could be harm to the public, and a host of issues that could come with not addressing the issues. The Resolution on the agenda was to solicit proposals for a Police Consultant. Mr. Moench said that in his opinion, the issues could not be resolved internally and there needed to be outside help.

Councilwoman Pirrera said that from a financial standpoint, if they were to create a position that was going to cost a lot of money, the public had the right to know why. She said that the BCPO report was delivered to her house even though she was exempt from police matters.

Mr. Moench said that from a legal standpoint, the Governing Body needed to keep in mind that there are matters that come before the Governing Body that the public is not privy to. Discussions of litigation, contracts, public safety, etc. The report contained certain areas that talk about staffing, issues about administrative matters, things that could wind up causing the Borough to be exposed to legal liability, exposed to actual harm to police officers, etc. Given the fact that it was a report from one government agency to another regarding public safety matters, it was his opinion that the report did not have to be released. The Governing Body had already alerted the public about the report from the BCPO, which contained recommendations on the areas of the Police Department that need to be improved.

The Mayor and Councilwoman Jang discussed the Police Consultant and the BCPO Report.

Mr. Moench spoke about Resolution #2023-79. Mr. Lorenzo, in his role as the Borough Administrator, he was subpoenaed to testify, which was done by several members of the Governing Body. In the course of that litigation, he had to appear in court, not of his own volition. The Borough could choose to indemnify him. There was discussion about whether or not the Plaintiffs requested payment for their legal fees. Councilwoman Pirrera wanted to see the bills that were submitted. The Deputy Borough Administrator, Austin Ashley said that the bills could be supplied by Plaintiff's counsel.

Councilwoman Jang asked if any action needed to be taken on the Ordinances. The Borough Clerk said no.

Councilwoman Jang stated that she received two items on the Off Consent Agenda late. Mr. Moench said that there were couple items on the Agenda that were delayed. He stated that there were always going to be items that come up late because the Governing Body cannot wait a month on certain items. The Mayor suggested that the Council read the Agenda and call with questions instead of waiting 10-15 minutes before the meeting to ask questions.

Mr. Ashley stated that the amount reflected in Resolution #2023-74 was going to be \$43,900.00.

COUNCIL REPORTS:

There were no Council reports.

PUBLIC PARTICIPATION:

Councilman Kim made a motion to open to the public. Councilman Min seconded. The motion carried. All present in favor by voice vote; none opposed.

Marsha Schor said that Councilwoman Jang should address the Mayor when speaking. Ms. Schor mentioned that in previous years, the Police delivered the agenda to the Governing Body. She asked if this could be done again to ensure that everyone got the agendas in time.

Susan Brauer asked that the tax rate would be. The Chief Financial Officer, Roy Riggitano, said that the rate was 1.6. He said this was going to go down, and it was a work in progress.

Travis Park spoke about the traffic control problems during school dismissal hours. Councilman Vietri made a recommendation to get a hold of Chief Espino regarding this problem. There was discussion of hiring crossing guards.

Youbong Won-Yoon asked about Resolution #2023-66. Mr. Moench explained that money was found, and the unclaimed funds were being given back to the person who found the cash. She asked about #2023-68. Mayor Kim answered that the Police Consultant was needed to rectify the BCPO findings in their report. Mr. Moench stated that the report had not been made public. She asked about #2023-69. The Clerk Kim clarified that Resolution #2023-1 was being amended. She asked about the meeting dates for the Governing Body. Mayor Kim said that the Council would be voting on the dates and times. She asked about the redactors for Daniel's Law. Clerk Kim stated that Governor Murphy passed a law stating that certain addresses of Judges, Prosecutors, and Police Officers needed to be redacted citing public safety concerns. The Borough needed to designate official redactors who would be responsible for redacting the addresses for said Officials. She wanted to know if Borough jobs can be made available to the public. She asked about the Docket Number for Resolution #2023-79. She asked about #2023-80. Mr. Moench said that Resolutions #2023-79 and #2023-80 were related to the same case, and in general, when a Borough employee or Borough official is the defendant in a lawsuit, they are almost always covered in their defense costs by the municipality. She asked about the temporary capital budget. Mr. Riggitano stated that this needed to be adopted with the Bond Ordinance. She asked about the deferred school taxes Resolution. Mr. Riggitano answered. She asked about the Parking Fees Ordinance. Mayor Kim answered. She spoke about her property assessment. Mr. Ashley answered that it was beneficial to have more assessments because if you do not have assessments, one could get a large assessment every 10 years.

Neeris Papoters asked about the Police Consultant. She wanted to know why the Borough always had to pay for the legal fees. Mayor Kim addressed her questions.

Youngmin Jung spoke about his qualifications as a translator. He said that he volunteered as a Borough translator, and he was never paid. The Mayor asked what he wanted to address to the Governing Body, and he asked Mr. Jung not to speak about politics at the meeting.

Peter Longo requested that meeting notices be posted on the website. He suggested that notices be sent out through Nixle. He hoped that job openings would be posted on the website.

Karen Nascenti stated that the crossing guards were very thankful for their raises.


Clerk Kim stated that Resolution #2023-85 authorizing the appropriation transfers would be added to the Off Consent Agenda.

Rebekah Lee said that there is a sewer drain that she cleans out at the corner of Abbott Ave and Edsall Ave. Mr. Ashley stated that the DPW would take care of the issue.

Youbong Won-Yoon asked for the Docket Number for #2023-79. Mr. Moench read the Docket Number to her. She asked when the minutes, ordinances, and budget would be posted on the website. The Clerk stated it would be posted the next day. She asked about the reassessment. Mayor Kim answered.
