The Mayor asked if this was normal procedure. The Mayor stated that this was received over the weekend, and he was sick and tired of getting such an important thing like spending an extra 13 million dollars in August.

Mr. Riggitano stated that he was approached by the Police Chief and other personnel that they needed emergent equipment. He went over it with the Administrator. Mr. Riggitano prepared the bond ordinance with bond counsel.

Councilman Min asked if this was a part of the 2<sup>nd</sup> reading of the bond ordinance. He stated that at the last Special Meeting, this bond was talked about specifically. He requested a copy of the details of the bodycam invoice. He said that money was already spent to purchase the bodycams. This was for the first set of bodycams. Since then, the Attorney General requested an upgrade to the initial bodycams.

Mr. Lorenzo stated that the initial bodycams were purchased with grant monies that the Borough had gotten as well as confiscated funds.

Councilman Min wanted to know the details of the invoice. Mr. Lorenzo stated that he had asked Officer Robert DeVito to send the invoice. The Mayor stated that he had not gotten it. The Mayor read Bond Ordinance #2023-12 into the record. Councilman Min stated that he would like to table the Capital Budget.

Councilman Min made a motion to table Resolution #2023-191. Councilwoman Jang seconded. The motion carried on a roll call vote and was recorded as follows:

Ms. Kim asked the Mr. Collins if tabling the Capital Budget Amendment impacted the 2<sup>nd</sup> reading of Bond Ordinance #2023-12.

The Mayor said it was confusing because the 2<sup>nd</sup> reading ordinance was put into the budget. Mr. Lorenzo stated that the Capital Budget Amendment needed to be adopted to provide for the bond. Mr. Collins stated that given that reasoning, it was up to the Governing Body's discretion to have the public hearing on the bond ordinance tonight but not vote on the adoption.

The Mayor had questions about capital improvements. Mr. Riggitano stated that those questions should be asked in Executive Session for homeland security purposes.

Mr. Collins stated that there were two Resolutions that the Council needed to consider:

1. Resolution approving entry into settlement agreement - Wang & Cheng v. Borough of Palisades Park, et. al. BER-L-6227-22. This was a private property dispute and the Borough was named as a party due to applicable zoning considerations. This did not involve any costs or payments by the Borough.

Mr. Collins clarified that this would resolve two litigations involving the Police Department. It was on delegated authority. The Mayor said there was a reputation of settling a lot of lawsuits. The recommendation was from the Borough Attorney and JIF to do the right thing.

Mr. Lorenzo stated if the Council was going to make a committee for the planner. Mr. Collins stated that there should be a motion from the Governing Body to appoint members to the committee. The Mayor said that the Council agreed on a committee. Mr. Lorenzo said that time was of the essence.

#### 2<sup>ND</sup> READING/PUBLIC HEARING:

ORDINANCE 2023-12

Bond Ordinance to Authorize the Acquisition of New Information Technology Equipment, New Additional or Replacement Equipment and Machinery and a New Automotive Vehicle, Including Original Apparatus and Equipment, for the Use of the Police Department In, By and For the Borough of Palisades Park to Appropriat the Sum of \$372,500

Councilwoman Jang made a motion to open Ordinance #2023-12 to the public. Councilman Park seconded. All present in favor by voice vote; none opposed.

#### **PUBLIC PARTICIPATION:**

Ms. Brauer asked if there were members of the Council who did not understand the Ordinance. Mayor Kim stated that some people did not get the breakdown of the information. She asked if this Ordinance would be tabled again.

Mr. Lorenzo stated that the public would be able to participate, but there would be no vote until such a time when the Mayor and Council had all of the requested information. Mr. Collins stated that the legal requirement was for a 2<sup>nd</sup> hearing and public hearing, which was being done. The Council would not be taking action because of the Council voting to table the previous corresponding Capital Budget Amendment, but the Council could bring it back up at the next meeting.

Ms. Brauer asked if the public had to be at the meeting when this bond ordinance would be adopted. Mr. Collins stated that the public had the right to be at the meeting but the public was not obligated.

The Mayor said that he was not delaying this, but he wanted to know exactly what the bond ordinance

Ms. Brauer asked when they realized they did not have the information that was requested. Mr. Lorenzo stated that he circulated the information that he had. The bodycam information was requested to Officer Robert DeVito. Ms. Brauer suggesting asking Councilman Min to be in charge of making sure that everybody had all the information on every item on every bill so that the Governing Body did not have to go through this again. The Mayor said that if the administrative staff gave the information that was requested, which they had, the Governing Body would not be in the current situation. If Councilman Min had to do that, he should get paid extra.

Marsha Schor stated that there were meetings two-three times a week. There was Executive Session while the public sat there and it was not fair. Ms. Schor stated that when the Mayor was on the Council, he did not question anything that he was questioning now. The Mayor said it was because he was a Councilman. Ms. Schor wanted to know what that had anything to do with what he was doing now. The Mayor said they needed reform and change. The Mayor said he was trying to protect the public from expenses. Ms. Schor stated that the Governing Body got the agenda before the public so they were supposed to read what they were getting. Ms. Schor asked why the public had to go through this every two-three times a week. The Mayor said it was because he got the information late. He wanted the itemized list.

Neris Papoters said she really liked the Mayor asking questions.

The Mayor said that 28-29 million dollars were authorized in May, and they were asking for 13 million dollars. Mr. Lorenzo stated that the total budget was about 50 million. The Mayor said they needed clarification and see everything.

Councilwoman Jang made a motion to close to the public hearing and table Bond Ordinance #2023-12 until further consideration of that alongside the Capital Budget Amendment. Councilman Kim seconded. The motion carried on a roll call vote and was recorded as follows:

Councilman Min spoke up the Police Records Clerk job posting on the Police Department and Borough website. He stated that resumes would be accepted, interviewed, and the most qualified candidate would be hired.

Councilman Vietri asked what would happen to the Records Clerk who was recommended for hire by the Police Chief.

Councilman Min stated that he wanted to be involved as a member of the Police Committee. Councilman Vietri asked if he would get involved with hiring other personnel. Councilman Vietri stated that the Police Chief interviewed the applicant, conducted a background check, and requested to hire him. Councilman Min asked the Police Chief if he sent him a copy of the resumes of the people who applied. The Chief answered no. Councilman Min asked why he was not notified. Chief Espino stated that the Police Committee and the Mayor was notified after the background check and that he was recommending the applicant for hire. Councilman Vietri stated that he received the email.

Councilman Min made a motion for the Chief of Police to advertise on the Police website, Borough website, and a copy in the newspaper. Councilman Park seconded. The motion carried on a roll call vote and was recorded as follows:

#### **COUNCIL REPORTS:**

Councilman Park had no report.

Councilman Vietri had no report.

Councilman Kim stated that September 7<sup>th</sup> was the first day of school. He was sure that all the parents were excited about that. The school was supposed to have one more pre-kindergarten class. There was a problem that was being rectified. If the problem resolved, there would be one more pre-k class. The Mayor asked about getting extra spaces through grants. They were still waiting.

Councilwoman Jang had no report.

Councilman Min announced to residents that the Borough now had an open position for hire.

The Mayor said that it was never too late to change. When he read about the budget from last year to now, he said they were in a business that could not lose. If it was over budget, he did not know where the money went. If it was under budget, then he could come back and say to do the bond and appropriations and amendments. His main goal was to sit down with the CFO in the coming weeks and study the budget.

Councilwoman Jang asked if there was an executive budget report for 2022.

The Mayor stated that he thought he could save millions of dollars.

## **PUBLIC PARTICIPATION:**

Councilman Min made a motion to open to the public. Councilwoman Jang seconded. The motion carried. All present in favor by voice vote; none opposed.

Susan Brauer asked about the details of credit card payments. The Mayor stated that the Resolution allowed going forward and digitizing types of payments accepted. Mr. Collins stated that an RFQ would go out, and after that the Governing Body would take action after.

Ms. Brauer asked about Resolution #2023-193. Mr. Collins explained that there were two pending lawsuits against the Borough. The Resolution delegated authority for the Borough Attorney and Special Counsel to negotiate a settlement agreement with terms put forth in Executive Session. This allowed for

negotiaton for final terms. Once the settlement agreement was finalized, it could be OPRA'ed. The Resolution was not written yet.

Ms. Brauer asked about posting the job about the Records Clerk. In her opinion, it sounded like the Mayor was unhappy with the person that the Chief recommended because it was not someone the Mayor had picked. She said that the Mayor and Council was wasting time and money. She stated that the Mayor did not know any more about the Police Department today than he did when he was on the Council.

Mr. Collins stated that the Governing Body was required to meet in public in order to go into Executive Session. There was discussion about having the Executive Session after the public participation. However, there was potential action that needed to be taken after the Executive Session, which were the items added to the agenda. From a scheduling standpoint, if the Governing Body knew how long the Executive Session would take, there could be steps taken to better advise the public.

Peter Shin stated that there needed to be food next time there was a meeting like this. He knew that the Governing Body was working hard, but he was bored and lonely. The Mayor stated that the meeting was this way because information was received over the weekend. He stated that nothing would be accepted for the agenda after the third Monday. Mr. Shin stated he wanted to know the details of the budget. The Mayor agreed.

Rebekah Lee stated with regard to the Executive Session, she agreed with everyone. She asked if the applicants who already applied and were interviewed had to do so again. The Mayor stated that all were included.

Melanie Comas spoke about the speed limit on Grand Ave. The Mayor asked Mr. Lorenzo what the Mayor could do to lower the speed limit. Mr. Lorenzo stated that the Police Department could send a letter to the State. The Mayor asked Chief Espino if it would be ok to lower the speed limit to 30 MPH. Chief Espino said that a survey would be needed. He would reach out to the State and justify the reasons for suggesting a lower speed limit. The Mayor asked Captain Gasparovich to reach out to the State. The Mayor asked who the traffic engineer was. It was Hal Simoff. The Mayor wanted the Council to ask Mr. Simoff conduct a traffic study on Grand Ave. Mr. Lorenzo stated that it was better if the Police Department contacted the State as Mr. Simoff would not have applicable traffic data to conduct a study. Ms. Comas stated that the cars were driving too fast. The Mayor suggested writing a letter stating that the Borough would like the speed limit to be reduced to 30 MPH because the speeding may create accidents.

Ms. Comas said the Borough needed a sign entering and leaving Palisades Park.

Ms. Comas said there was a lot of trailer traffic on Grand Ave. She spoke to NJ DOT, and the Borough should call traffic engineering of the DOT to look into this matter.

Ms. Comas stated that power-operated bicycles were all over the place and were not allowed on the sidewalk. Captain Gasparovich answered it depended on the speed and power supply.

Jane Kim said that she supports Councilman Min, and she wanted transparent posting of jobs so that the seniors could know. She said that the senior citizens had the right to know what was going on in town.

Loretta Martini said that she had been attending the meeting for 7-8 meetings, and she wanted to know what was going on in the meetings. She said the Council had a job here, and it was rude to leave during the meeting.

Gilim Kang stated that she was happy to see that the Borough was trying to be transparent. She wanted to thank the Mayor and Council. She stated it may be hard, but she would like to see the transparency continue. She said she would continue to support the Mayor and Council, and she was honored and proud.

Youbong Won-Yoon said it was good to hear that the job opening was on the website. She hoped it was not limited to the Police Records Clerk. She said the financial statement was not on the website. The audit was not adopted yet. She found a whole unit development at the corner of Highland and W. Washington Place. There was no builder sign or no permit sign. She found the Borough Administrator's name on the materials. Mr. Lorenzo stated that he was not the owner. Ms. Won-Yoon stated that not putting the builder sign or permit sign was illegal. Mr. Lorenzo stated he was not the builder on that job. Ms. Won-Yoon thought there was a conflict of interest. Mr. Lorenzo stated that there was no conflict. She stated that Mr. Lorenzo was a builder, and he was also on the Planning Board. Mr. Lorenzo stated that he did not vote on that application, and the Building Department cleared any conflicts.

Ms. Won-Yoon requested the Mayor to resolve the conflict. She found another development on W. Palisades Blvd and Hillside Ave. The builder name was PBS. She thought it was Elefteriou. Ms. Won-Yoon stated that Mr. Elefteriou was on the Planning Board. Mr. Lorenzo corrected that he was on the

Board of Adjustment. The Mayor stated that legally, he asked if he could build in town. Mr. Lorenzo said yes, and that the Mayor does build in town and he had every right to. Mr. Lorenzo stated that as long as the person sitting on the Board does not vote on the application, there was no conflict. This was State law.

Peter Longo said he was glad to see the posting of positions. He asked if this would continue with every position for crossing guards or police officers. He asked about the website. The Mayor wanted to know who was in charge of the website when he was being paid \$40,000. The Mayor asked the Borough Administrator to ask someone to update the website. He suggested updating the website to include announcements regarding park openings.

Councilman Min explained the difference between the hosting company and the person who actually controlled and made changes on the website.

Ms. Papoters stated that Youngsam Choi used to update the website. She wanted an update with the fire code violations. The Mayor said that through the cooperation from the State and the local fire official, it has been productive and he expected good things were going to happen. She commented on the credit cards at the pool.

Rebekah Lee stated that on Brinkerhoff Ave, there was a "dangerous intersection" sign. The sign was working.

Ms. Won-Yoon spoke about a webmaster. Every website had a webmaster. Mr. Lorenzo recommended the job be given to Youngsam Choi. Mr. Lorenzo asked how much the Mayor wanted to pay as a stipend. The Mayor said they would talk about it later.

Councilwoman Jang made a motion to close to the public. Councilman Kim seconded. All present in favor by voice vote; none opposed.

#### **ADJOURNMENT:**

There being no further business to come before the Mayor and Council, Councilman Min made a motion to close to the public and adjourn. Councilwoman Jang seconded. All present in favor by voice vote; none opposed. Meeting adjourned at 9:10 P.M.
