The Borough Clerk confirmed with the Borough Attorney that Kauker and Kauker had been hired as the Special Planner. The extra services rendered would be discussed.

COUNCIL REPORTS:

There were no reports from the Council.

PUBLIC PARTICIPATION:

Councilwoman Jang made a motion to open to the public. Councilman Min seconded. The motion carried. All present in favor by voice vote; none opposed.

Youbong Won-Yoon asked about the insurance for Resolution #2023-195. She stated that insurance could not be bought until the event was authorized. She asked about Resolution #2023-196 and why Kauker and Kauker was being hired. Ms. Tagarelli answered that they were hired as expert witness opinions for the ongoing litigation with the Borough and Reexamination/Master Plan. Ms. Won-Yoon asked about settlement. The Mayor answered that he could not say he was trying to settle, but rather they were protecting themselves.

Neris Papoters thought the Special Meeting was to discuss about the budget. The Mayor stated that he was working on it, and hopefully he would have good news. Ms. Papoters asked if the meeting would always take place on a Monday. The Mayor said that they made it so that the Governing Body would have ample opportunity to review and assess and judge before they make their decision. By the third Monday, they were supposed to receive every agenda and resolution that was supposed to be passed. That third week, Councilmembers would have ample time to review it and ask questions for the fourth Monday. She asked about the status of the job posting. The Mayor said it was a technical situation, which he did not get. It was a simple procedure. He stated that someone needed to get content to the webmaster to post. He wanted someone to be paid a stipend to temporarily take care of the website until a suitable resolution was found.

Councilman Min said that he was checking on the website every day, and so far three was no posting. He emailed the Police Chief again.

Councilwoman Jang made a motion to close to the public. Councilman Min seconded. The motion carried. All present in favor by voice vote; none opposed. Ms. Papoters asked if the website would post other positions. The Mayor stated that he could it himself because it was not difficult. The Borough Clerk with regard to the job posting, the Police Chief had forwarded to the Police Committee, a letter was forwarded to the Mayor as well, a job description for the Police Records Clerk. The Chief just needed approval to post it on the website. Councilman Vietri stated that he received it. The Mayor said he told the Chief and the Borough Administrator not to comingle what they needed to do. The Police Department should handle their own website. They should find their own webmaster.

Ms. Won-Yoon said that someone had been updating the website to announce the meetings. She asked why the information could not be posted there. The Mayor stated that none of the administrative staff wanted to take that on. She wanted to know who was posting the meeting notices. It was the Borough Clerk. The Mayor said this was a simple problem, which required a simple solution.

The Mayor said he wanted to know if there was a proper way to post jobs. He wanted to find this out from the attorney.

Councilman Vietri stated that Chief Espino sent out an email earlier to himself and Councilman Min. Councilman Vietri saw the emails. Chief Espino had done his job.

RESOLUTION AWARDING PROFESSIONAL SERVICES CONTRACT FOR MASTER PLAN REEXAMINATION PLANNING SERVICES

WHEREAS, procurements completed by the Borough are governed by the Local Public Contracts Law, N.J.S.A. 40A:11-1 et seq.; and

WHEREAS, N.J.S.A. 40A:11-5(1)(a)(i) exempts from bidding professional services; and

WHEREAS, the Borough is in need of a professional planner, which is a licensed professional satisfying the definition of professional services under N.J.S.A. 40A:11-2(6); and

WHEREAS, the Borough has received a proposal from Kauker & Kauker LLC to provide such services, at a total cost of \$18,500.00, upon the terms set forth in the proposal attached hereto and incorporated by reference; and

WHEREAS, to the extent required by the provisions of N.J.S.A. 19:44A-20.4 et seq., the entity shall complete and submit a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Borough of Palisades Park in the previous one year, and that the contract will prohibit same from making any reportable contributions through the term of the contracts, pursuant to N.J.S.A. 19:44-20.5 et seq., which shall remain on file for 10 days prior to the Borough entering into any contract with the entity; and

WHEREAS, the Chief Financial Officer has certified as to the sufficiency of funds.

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Palisades Park hereby awards a professional services contract to Kauker & Kauker LLC, in the total amount of \$18,500.00 consistent with the foregoing.

BE IT FURTHER RESOLVED that the Mayor and Borough Administrator are hereby authorized and directed to execute a professional services contract, consistent with the foregoing, and subject to the review and approval of the Borough Attorney as to legal form.
