**AN ORDINANCE AMENDING CHAPTER 116 OF THE CODE OF THE
BOROUGH OF PALISADES PARK ENTITLED "CONSTRUCTION CODES, UNIFORM"**

BE IT ORDAINED, by the Mayor and Council of the Borough of Palisades Park, County of Bergen, State of New Jersey that Chapter 116: "Construction Codes, Uniform" of the Code of the Borough of Palisades Park is hereby amended as follows (~~stricken~~ text deleted; underlined text added):


