Ms. Schor said that initially there was a roster so the Officers could take turns. Captain Gasparovich explained that EDS would manage that roster. It would be computer-generated, so there would be no favoritism. The positive of using this company was that they would pay the Borough right away for the road details.

The Mayor asked a question about the billing and the 6% with a minimum of 4 dollars per hour. This cost would not be paid by the Borough. All expenses would be passed onto EDS. Captain Gasparovich said that the majority of neighboring towns were using this company. The Mayor said he wanted to get a copy of their insurance.

## AUTHORIZATION OF AGREEMENT WITH EXTRA DUTY SOLUTIONS

WHEREAS, this year, the Borough Council enacted Ordinance 2023-11 titled "Ordinance Addressing the Contracting of Off-Duty Police Officers or Other Law Enforcement Officers"; and

WHEREAS, pursuant to same, the Borough seeks to enter into a contract with a vendor to provide services relating to the management of off-duty police and other law enforcement officer assignments; and

WHEREAS, the Borough has obtained a proposal from Hart Halsey LLC d/b/a Extra Duty to provide such services upon the terms generally set forth in the attached proposed contract, including compensation through an administrative fee of 6% with a minimum of \$4.00 per hour; and

WHEREAS, the Borough estimates that this contract shall have a total value of \$80,000.00, and that the Qualified Purchasing Agent recommends its award, allowing for it to be awarded without bid pursuant to N.J.S.A. 40A:11-3; and

WHEREAS, to the extent required by the provisions of N.J.S.A. 19:44A-20.4 et seq., the entity shall complete and submit a Business Entity Disclosure Certification which certifies that they have not made any reportable contributions to a political or candidate committee in the Borough of Englewood Cliffs in the previous one year, and that the contract will prohibit same from making any reportable contributions through the term of the contracts, pursuant to N.J.S.A. 19:44-20.5 et seq., which shall remain on file for 10 days prior to the Borough entering into any contract with the entity; and

WHEREAS, the Chief Financial Officer has certified as to the sufficiency of funds.

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Palisades Park hereby awards a contract to Hart Halsey LLC d/b/a Extra Duty, consistent with the foregoing.

BE IT FURTHER RESOLVED that the Mayor and Borough Administrator are hereby authorized and directed to take any and all steps reasonably necessary to effectuate the foregoing, including execution of the a contract with the foregoing vendor, upon terms subject to the review and final approval of the Borough Attorney.
