New Plates for Limo Owners (Livery)

Limousines are defined in the new laws as all Motor Vehicles with a seating capacity of up to 15 persons, including the driver, engaged in prearranged passenger transportation for a premium fare operated on a dedicated non-scheduled basis and not conducted on a regular route.

The limousine designation does not include taxicabs, hotel or airport shuttles and buses, or vehicles owned or operated without charge by a business entity for its own purposes.

All applicants must provide the following:

1- The municipal license or certificate issued by the municipality where the service is principally located.

2- A "Power of Attorney" appointing the Director of the Division of Motor Vehicles their true and lawful attorney for the acceptance of service of process.

3- An insurance certification including the name of the insurance company, the number and date of expiration of the policy, and a description of all vehicles covered under the policy. <u>Liability</u> coverage must be for \$1.5 million.

All of the required documentation must be presented at a Motor Vehicle Agency in order to affect the registration renewal and plate replacement
