

Notice is hereby given that sealed proposals will be received by the Mayor and Council, Borough of Palisades Park, Bergen County, New Jersey (the "Owner") for the Broad Avenue Streetscape Project – Phase 3 project and be opened and read in public at the Borough of Palisades Park Municipal Building, 275 Broad Avenue, Palisades Park, NJ 07650 on Wednesday, May 13, 2026 , at 10:00 AM prevailing time.

Please note that this project is a rebid of a project originally bid on April 14, 2026.

Copies of plans, specifications, and contract documents may be obtained beginning Wednesday, April 29, 2026, upon request by emailing the Clerk's Office at sjang@palisadesparknj.gov. Physical copies may also be obtained beginning on that same date upon payment of \$90.00, said sum not refundable, at the Clerk's Office, Municipal Building, 275 Broad Avenue, Palisades Park, NJ 07650, between the hours of 9:00 A.M. and 4:00 P.M., prevailing time, Monday through Thursday, excluding legal holidays.

Each bid must be made upon the prescribed forms, furnished with the Contract Drawings and Specifications, including the non-collusion affidavit and disclosure statement and must be accompanied by a Consent of Surety and a certified check, cashier's check, or Bid Bond of not less than ten (10%) percent of the amount bid and, not to exceed \$20,000.00. Such checks and Bonds shall be made payable to the Owner and will be held as a Guarantee that, in the event the Bid is accepted and a Contract awarded to the bidder, the Contract shall be duly executed and its performance properly secured. The successful bidder shall furnish and deliver to the Owner a performance and payment bond each in the amount of 100 percent of the accepted bid amount as security for the faithful performance and payment of the Contract. Further, the successful bidder must furnish the policies or Certificates of Insurance required by the Contract. In default thereof, said checks and the amount represented thereby will be forfeited to the aforesaid Owner as liquidated damages. Bids must be accompanied, in the case of corporations not chartered in New Jersey, by proper certificate that such corporation is authorized to do business in the State of New Jersey.

Bidders are required to comply with the requirements of P.L. of 1975, C.127 (N.J.A.C.17:27) regarding Affirmative Action & Executive Order 11246 regarding equal employment opportunity, as amended. All corporations and partnerships must comply with Chapter 33, of the P.L. of 1977, regarding disclosure of partners and stockholders.

Each bid must be enclosed in a sealed envelope bearing the name and address of the bidder, addressed to the Owner and labeled for the: Broad Avenue Streetscape Project – Phase 3.

The successful bidder will be required to comply with all provisions of prevailing wage rates as determined by the New Jersey Department of Labor and Federal Department of Labor (Davis-Bacon Act).

All bids shall be irrevocable, not subject to withdrawal and shall be available for a period of sixty (60) days.

A Pre-Bid meeting may be held based on the number of questions raised by the Bidders. The Owner reserves the right to reject any bids, to waive informalities or irregularities in the bids received and to accept the bid from the lowest responsible bidder.
